The Probe class at Jones Elementary School will be participating in a field trip to **McWane Science Center in Birmingham, Alabama on Friday, March 16**. Transportation for this field trip will be by school bus to and from the site. The group will leave from Jones Elementary at 7:30 and return to school by 4:30. This form must be completed and returned with the cost of the trip by **Friday, March 2**, in order for the student to participate.

The cost of the trip for our school is **\$16.00** per child. This includes the cost of admission, transportation, and bus drivers. Your contribution will help us to defray the cost of the field trip for your child. This donation will be used specifically for expenses incurred in providing class trips. No child will be denied participation or otherwise penalized for the lack of a donation. If we are unable to take the trip due to weather, inability to finance the trip, or other circumstances, your contribution will be refunded.

***We will eat a picnic lunch on site. Your child will need to bring a sack lunch and drink, or purchase a sack lunch and drink from the lunchroom at the regular lunch price.***

We have a limited number of adult tickets available at **\$16.00** each. Parents will need to provide their own transportation for the trip. You may want to contact other parents to arrange car pools. Please do not drive between the school buses. Parking is available at the Presbyterian Church. We request that parents park at the church and please do not block any doors of the church.
